

**HATTIE LARLHAM 60<sup>th</sup> DIAMOND ANNIVERSARY RAFFLE  
OFFICIAL RULES**

1. **General.** By participating in the “Hattie Larlham 60<sup>th</sup> Diamond Anniversary Raffle” (the “Raffle”), being conducted by the Hattie Larlham Foundation, all entrants agree to be bound by these “Official Rules” and by the decisions of Hattie Larlham Foundation which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state, and local laws and is void where prohibited.
2. **The Raffle Period.** The ticket sales for the Raffle will begin at 12:00 am EST on August 30, 2021 and end at 7:00 pm EST, on October 23, 2021 (the “Raffle Period”).
3. **Prizes.** A total of ten (10) prizes will be awarded in the following order to the first ten (10) raffle tickets drawn randomly. Prizes will be awarded to the individual whose name appears on the raffle ticket. Purchasers of the raffle ticket will not be deemed to be the winner unless his/her/their name appears on the raffle ticket.

4. **The Grand Prize.** The “ Grand Prize” to be awarded is a 2021 Buick Encore (Vehicle Identification Number KL4MMBS21MB067484). The Winner is responsible for all federal, state, and local taxes, fees, and other governmental assessments on the awarded Grand Prize. Hattie Larlham Foundation and Hattie Larlham Center for Children with Disabilities assumes no responsibility for the Winner’s taxes and/or legal obligations and suggest that the Winner consult a tax and/or legal advisor. The Winner shall be responsible for license, title, tags, and registration fees. In addition, all costs incurred subsequent to transfer, such as gasoline, oil and maintenance, not specifically covered under the vehicle warranty are the Winner’s sole responsibility. The automobile is awarded “**AS IS**” with no warranty or guarantee, either express or implied by Hattie Larlham Foundation or Hattie Larlham Center for Children with Disabilities, except as specifically provided by the vehicle manufacturer. The Winner must claim the Grand Prize within thirty (30) days of notification, otherwise such

Grand Prize shall be forfeited. In the event that the Winner does not claim the Grand Prize or is determined to be ineligible to receive the Grand Prize, no Grand Prize shall be awarded or substituted. The Winner agrees to take delivery and title of the Grand Prize at Hattie Larlham Foundation, 9772 Diagonal Road, Mantua, Ohio 44255 and is responsible for transporting the automobile from 9772 Diagonal Road, Mantua, Ohio 44255 to the Winner's residence; and must provide evidence of insurance and a valid driver's license before picking up the vehicle. The Winner must also provide Hattie Larlham Foundation with all necessary information required for tax purposes prior to deliver of the Grand Prize. Failure to do so within ten (10) days of such request shall result in an automatic forfeiture of the Grand Prize. Participants in this contest authorize VanDevere Inc., to notify them of future dealer events via email.

5. **Award of 2<sup>nd</sup> to 10<sup>th</sup> Place Prizes.** As applicable, all Winners are responsible for all federal, state, and local taxes, fees, and other governmental assessments on the awarded Prize. Hattie Larlham Foundation and Hattie Larlham Center for Children with Disabilities assumes no responsibility for the Winner's taxes and/or legal obligations and suggest that the Winner consult a tax and/or legal advisor. All Winners must claim their Prize within thirty (30) days of notification, otherwise such Prize shall be forfeited. In the event that a Winner does not claim a Prize or is determined to be ineligible to receive the Prize, that Prize shall not be awarded. All Winners must also provide Hattie Larlham Foundation with all necessary information required for tax purposes prior to deliver of any Prize. Failure to do so within ten (10) days of such request shall result in an automatic forfeiture of the Prize.
6. **Eligibility.** The Raffle is open to all legal residents of the United States, who are eighteen (18) years or older as of the date of entry. All federal, state, and local laws and regulations apply. Void where prohibited by law. Employees of Hattie Larlham Center for Children with Disabilities are eligible to participate in the Raffle. The purchaser of a Raffle Ticket must be physically present in the State of Ohio at the time of the purchase of the raffle ticket.
7. **Purchasing Raffle Tickets.** All Raffle Tickets may be purchased as follows: (a) one (1) Raffle Ticket for \$25.00; or (b) six (6) Raffle Tickets for \$100.00. There are no discounts or complimentary Raffle Tickets available. Raffle Tickets may be purchased in person or online through the Hattie Larlham website. There is no limit to the number of Raffle Tickets an individual may purchase. Hattie Larlham Foundation shall be the sole judge of the validity and eligibility of all entries. All Raffle Ticket purchases shall be final, and no refunds or replacement will be issued by Hattie Larlham Foundation. Raffle Tickets are only valid for the drawing held on October 23, 2021.
8. **Raffle Tickets are Not Tax Deductible.** Under IRS guidelines amounts paid for chances to participate in raffles are not gifts and therefore the price of the Raffle Ticket does not qualify as a deductible charitable contribution to the Hattie Larlham Foundation.
9. **Selection of Winners.** Ten (10) Raffle Tickets will be drawn to determine the winners of the Prizes. The drawing will occur on or about 7:30 pm on October 23, 2021.

10. **Federal, State and Local Taxes.** The Prize winners will be responsible for any and all federal, state, and local taxes, fees, and other government assessments on the awarded Prizes. The Prize winners acknowledge that federal law requires a tax withholding on certain prize values must be collected from winners upon award of the Prize. Federal, state, and local withholding laws are subject to change without notice. The withholding laws at the time the Prize is claimed will be followed. The Prize winner will receive a W-2G from Hattie Larlham Foundation as required by federal law.
11. **Odds.** Odds of winning are based on the total number of Raffle Tickets purchased during the Raffle Period.
12. **Transfer of Raffle Ticket.** Raffle Tickets shall not be resold to any party. Any Raffle Ticket which has been resold shall be void. All individuals who re-sell, purchase, or receive a Raffle Ticket in violations of these Official Rules shall be ineligible to participate in the Raffle or to win the Prize.
13. **Release of Liability.** By entering into the Raffle, all entrants agree to : (a) be bound by these Official Rules; and (b) release Hattie Larlham Foundation and Hattie Larlham Center for Children with Disabilities together with their members, employees, officers, directors, sponsors, representatives and agents, from any and all liability with respect to any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from participation in the Raffle, or from any travel or activity related to the receipt or use of the Prize.
14. **Publicity Release.** The Winner, by accepting any Prize, grants Hattie Larlham Foundation and its designees and affiliates, full permission, except where legally prohibited, to use such Winner's name, address (city and state only), photographs, voice and/or other likeness, and prize information for advertising, trade, and promotional purposes without further compensation and without notice, review, or approval, in all media now known or hereafter discovered, worldwide and in perpetuity. Each Winner shall execute all documents that Hattie Larlham Foundation may require to be signed in connection with this release.
15. **Governing Law.** The Raffle and Official Rules shall be subject to and governed by the laws of the State of Ohio. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular person or circumstance, is invalid or unenforceable to any extent, then the remainder of these Official Rules shall remain enforceable to the fullest extent permitted by law. The sole jurisdiction and venue for any cause of action arising out of the Raffle or these Official Rules shall be the courts located in Portage County, Ohio.
